### **POSITION SUMMARY:**

This position supports the work of the Dubuque Community YMCA/YWCA, a leading nonprofit committed to strengthening community through youth development, healthy living, social responsibility, empowering women and eliminating racism. Provides pre-kindergarten education to children ages 5 and under. Provides a quality experience to children and parents that focuses on foundational skills and by stimulating the desire to learn by introducing students to questioning, experimenting and problem solving.

### **ESSENTIAL FUNCTIONS:**

1. Prepare lessons that meet educational requirements in an age-appropriate manner, and teach in a manner suitable for the ages of all participating students.
2. Manage a busy classroom environment, and provide the structure and discipline required for successful learning for everyone in the classroom

4. Collaborate with other teachers, instructors, and staff members to create an optimal learning and care environment.
5. Provide helpful feedback to parents and guardians on a regular or as-needed basis.
6. Work with diverse populations of children and adults from a wide variety of cultural backgrounds
7. Prepare lesson plans for student according to the age, developmental maturity, and needs of the children being taught, while including fundamental vocabulary, simple shapes, basic colors, letters, and numbers into the curriculum.
8. Address basic interpersonal skills, such as sharing, taking turns, and asking permission in the classroom.
